A Bill for an ordinance approving the Ciling of certain streets in Districts Nos. One, Two, Three and Four in the City of Hopkins, Missouri.

Be it ordained by the Board of Aldermen of the City of Hopkins, as follows;

Section 1. Whereas by ordinance of the City of Hopkins No. 200 the City of Hopkins was divided into Four convenient Oiling Districts and whereas by resolutions of the City of Hopkins No. 10 passed by the Board of Aldermen of said city and approved by the Mayor of said City and whereas in pursuance of said Ordinance and said resolution the said Board of Aldermen has caused the following streets in said city to be oiled in said districts, as follows;

In Oiling District No. 1. Roseberry Street from the East side of Fourth Street to Railroad Street, Third Street from Barnard Street to One Hundred and Twenty feet South of Roseberry Street, Barnard Street from West side of Fourth Street to East side of Second Street, Railroad Street from Roseberry Street to Warren Street.

In Oiling District No. 2. Third Street from One Hundred and Twenty feet South of Roseberry Street to Caroline Street, Fourth Street from Roseberry Street to McPherson Street, Second Street from Morehouse Street to Caroline Street, First Street from Morehouse street to Caroline Street, Morehouse Street from First Street to Sixth Street, Sixth Street from North side Morehouse Street to Mc. Pherson Street, Roseberry Street from Fourth Street to Tenth Street, Second street from Morehouse Street to Roseberry Street.

In Oiling District No. 3. Barnard Street from Fourth Street to Eighth Street , Fourth from Roseberry Street to Warren Street, Fifth Street from Barnard to Craig Street, Craig Street from Fifth Street to Eight Street, Eighth Street from Craig Street to Mc. Farland Street, Mc. Farland Street from Eighth Street to center of Section One (1)

In Oiling District No. Four. Barnard Street from East side of Second Street to West side of Rinary Street, First Street from Barnard Street to
Warren Street, Warren Street from First Street to Second Street, Second
Street from Warren Street to Barnard Street.

And the said Board of Aldermen having examined said Oiled Streets in said Oiling Districts Nos. One, Two, Three and Four, and the costs thereof, the same is hereby approved.

Section. 2. This Ordinance shall be in force and effect from and after its passage and approval.
