De it Ordained by the Board of Aldermen of the City of Hopkins MO as follows, -:

All male persons between the age of -Twenty-one and Fifty Years, who have resided with-in the corporated limits of the City of Hopkins MO.for Thirty-days prior to the passage of this act, age hereby required to work on the Streets and Alleys of said City, Two-days for the Year 1920, or in lieu thereof, to pay to the Street Commissioner, of said City the Sum of Two-Dollars, and if said work is not done at the time, and place at and for which notice is given by the Street-Commissioner, said Two-Dollars, shall immediately become due and payable, and suit shall be brought for the collection thereof, according to Law, and the City Attorney, shall be allowed a fee of Five-Dollars(\$5.00) for bringing said suit which fee shall be taxed as costs against the defendent in such suit against whom Judgment is rendered.

This Ordinance shall be in force and effect from and after its passage and approval.
